

## CALL FOR APPLICATIONS – ATTACHMENT ERASMUS + PROGRAMME GRANT A.Y. 2020-2021

### **ELIGIBLE CANDIDATES**

All students regularly enrolled in the degree courses of Law and of Science of Administration and International Relations are eligible for the programme.

Departure of applicant is subject to the regulations of the host country and is to be approved by the host university.

The candidate is recommended to have a proven knowledge of the language spoken in the university of destination as requested by the agreement with the host university. Before the departure, candidates shall submit in any case a certificate indicating their level of language proficiency issued by an officially qualified institution.

### **MINIMUM MOBILITY PERIOD**

The minimum duration of the mobility period at the host University is **three months** (ninety days). Periods shorter than ninety days will not grant students the Erasmus+ status and the possible amounts already received shall be returned.

#### DEADLINES AND ASSIGNATION PROCEDURE

Applications have to be filled out and submitted online at <a href="http://mobint.uniroma2.it/erasmus/candidatura/Default.aspx">http://mobint.uniroma2.it/erasmus/candidatura/Default.aspx</a> by February 28, 2020

On the basis of the criteria agreed upon by the evaluating Committee, appointed by rectoral decree, the ranking list drawn up shall serve for one academic year (the duration of Erasmus+grants varies according to the host university).

Any appeals against the ranking list shall be justified and submitted in writing to the Committee within seven days from the publication of the ranking list.

The selected students shall formally accept the Erasmus+ grant by signing the related contract during a meeting that will be held in March 2020.

Non-acceptance of the grant shall result in its loss.

Departures are indicatively expected to be in August and September 2020 in relation to annual or first semester scholarships.

In order to be entitled to health care abroad, Erasmus+ grantees must hold a health insurance card issued by their municipality of residence.

Acceptance of disabled students is subject to the conditions provided by the host university. In order to have access to special facilities, in addition to the online application and within the



limits set by the law in force, disabled applicants may submit a further application on unstamped paper to the Erasmus+ office.

The students who are assigned an Erasmus+ grant are supposed to sign the online mobility agreement **before their departure**, otherwise they shall not be allowed for the Erasmus mobility.

Erasmus+ grantees may ask, before its end, to extend their mobility period, for justified study reasons. The form, duly filled out, must be sent to the Erasmus+ office of the Department of Law, which shall in its turn forward it to the responsible person of the University Erasmus+ Office. Please note that the payment of the grant for any additional period of stay abroad is not guaranteed. The person in charge of the University Erasmus+ Office shall ascertain the availability of remaining funds to be allocated for mobility extensions.

Before their departure, the selected students must submit their Learning Agreement agreeing on the modalities with the Erasmus + Office of the Department of Law, and wait for the Committee's approval.

Upon their return, grantees shall submit to the Erasmus+ office the **original copy** of the certificate related to the months spent at the host university ("**Registration and mobility period confirmation**" – attachment A), with a copy of the result of the OLS (Online Linguistic Support) final test. They shall also fill out the **Participant Report**, which they shall receive by the European Commission at the end of their stay.

## **VALIDATION OF EXAMS TAKEN ABROAD**

For students enrolled in the degree course of Law, exams shall be validated after the submission of a pre-printed form, filled out and accompanied by the original copy of the exams taken at the host University.

The exams listed below shall be taken only at the University of Rome Tor Vergata, De-

partment of Law. As a consequence, they cannot be taken elsewhere.

The maximum amount of exams per year that are eligible for validation is **seven**.

For new-system university students (i.e. *nuovo ordinamento*), foreign language proficiency exams (from 3 to 6 ECTS) shall also be validated.

For students enrolled in the degree course of Science of Administration and International Relations:

Exams shall be validated after the submission of a pre-printed form, filled out and accompanied by the original copy of the exams taken at the host University. A number of 60 ECTS is eligible for validation for one-year mobility grants, 30 ECTS for one-semester mobility grants.

Students participating in the Erasmus+ Programme (renouncers excluded) will be awarded with two more grades in the calculation of their final graduation mark for one academic year and one grade for one semester. The Erasmus+ programme grantees who will move to the host University only to acquire library resources for their dissertation will be recognized as «Erasmus+ Students»; however, their final graduation mark shall not be increased.

The marks of the exams taken abroad shall be converted according to specific charts approved by the Council of each School/Department.

For the validation of the exams taken at the host University, grantees shall submit:

- the original copy (Attachment A) certifying the duration of the mobility period;



- a copy of the result of the OLS final assessment test.

Grantees shall also fill out the online "Participant Report" on their experience abroad.

The University Erasmus+ Office shall issue an authorisation for the validation of exams taken abroad; the certificate is to be submitted to the Erasmus+ Office of the School of Law in order to get validation.

### ECTS CREDITS EARNING

In accordance with directions of the European Commission, the University requires that *new-system (i.e. nuovo ordinamento) university students* participating in the Erasmus programme shall earn a minimum amount of ECTS at the host University, equal to 2/3 of the total ECTS (CFU) provided for by the current study plan for one year. Since the total amount of credits to be earned in one year is 60, grantees spending one year abroad shall earn at least 24 ECTS, 12 ECTS for one semester grants (Ministerial Decrees N° 509/99 and 270/04). If this result is not achieved, the University shall not pay the Erasmus+ grant and any funds already paid shall be returned.

The University requests *old-system university students* (i.e. vecchio ordinamento) to take at least three exams.

ECTS earning is not requested for PhD students obtaining Erasmus+ grants.

The Erasmus+ Committee shall reserve its right to assess each single case.
